

INVITATION TO BID

BITUMINOUS CONCRETE

Sealed bids for furnishing BITUMINOUS CONCRETE to the City of Waltham will be received at the Office of the Purchasing Agent, City Hall, 610 Main Street, Waltham, MA, 02452, until **Thursday**, **September 6th**, **2018 at 10:00am** at which time they will be publicly opened and read.

Bids shall be submitted on the form furnished and in a sealed envelope marked on the outside with the bid title and the bidder's name.

Bid prices shall include street pick-up by the various Waltham Departments as may be required. Sworn-weight slips shall be provided to the City with every pick up.

The bid quantity is an estimate only and the City reserves the right to increase or decrease the quantity in accordance with its actual requirements.

The City may require samples of the Product offered prior to contract.

Purchases by the City are exempt from federal, state and municipal sales and excise taxes.

The City will award the primary contract to the lowest responsive and responsible bidder within forty five (45) business days of the bid opening. A secondary contract may be awarded to the next lowest responsible and responsive bidder.

The successful bidder will be required to provide a certificate of General Liability and Vehicle Liability Insurance in the amount of \$500,000 per occurrence and \$1,000,000 in the aggregate and workers compensation insurance.

The City reserves the right to reject any and all bids, in whole or in part, and to make awards as it determines to be in the best interest of the City.

This contract becomes effective upon the date of the Mayor's signature and will extend for a duration of one-year thereafter.
