INVITATION TO BID

BITUMINOUS CONCRETE

Sealed bids for furnishing WINTER BITUMINOUS CONCRETE to the City of Waltham will be received at the Office of the Purchasing Agent, City Hall, 610 Main Street, Waltham, MA, 02452, until **10:00 AM on Wednesday August 4th, 2021** at which time they will be publicly opened via Zoom. See our City's Website for meeting information.

Bids shall be submitted on the form furnished and in a sealed envelope marked on the outside with the bid title and the bidder's name.

Bid prices shall include pick up by the various Waltham Departments as may be required from October 1st, 2021 through September 30, 2022. Sworn-weight slips shall be provided to the City with every pick up.

The bid quantity is an estimate only and the City reserves the right to increase or decrease the quantity in accordance with its actual requirements.

The City may require samples of the Product offered prior to contract.

Purchases by the City are exempt from federal, state and municipal sales and excise taxes.

The City will award a primary contract and a secondary contract. The primary contract will go to the lowest responsive and responsible bidder for winter mix. A secondary contract will go to the lowest responsive and responsible bidder for winter mix. Contracts will be issued within forty-five (45) business days of the bid opening.

The successful bidder will be required to provide a certificate of General Liability and Vehicle Liability Insurance in the amount of \$500,000 per occurrence and \$1,000,000 in the aggregate and workers compensation insurance.

The City reserves the right to reject any and all bids, in whole or in part, and to make awards as it determines to be in the best interest of the City.

VIRTUAL/ZOOM BID OPENINGS

Bid results will be emailed to all vendors of record soon after the bid closes. A copy will be posted in the City's website, under the title of the bid of your interest.

DELIVERY OF SEALED BIDS
