Sealed bids for furnishing Safety Shoes to the City of Waltham will be received at the Office of the Purchasing Agent, Joseph Pedulla, City Hall, 610 Main Street, Waltham, MA, 02452, until **10:30 A.M. on August 15, 2011**, at which time they will be publicly opened and read.

Bids shall be submitted on the form furnished and in a sealed envelope marked on the outside with the bid title and the bidder's name.

Bid prices shall include delivery to the Waltham Public Works Department, 167 Lexington Street, Waltham, MA.

The use of a company or brand name in the specifications is intended solely to describe the standard of quality desired and shall, in no way, have the effect of exclusively requiring a proprietary product or purchase from a sole source. Bidders offering a substitute as an equal to that named in the specifications shall so indicate on the bid form. Samples of products offered may be requested by the City prior to contract award.

Purchases by the City are exempt from federal, state and municipal sales and excise taxes.

The City will award the contract to the lowest responsive and responsible bidder within forty five (45) business days of the bid opening.

The City reserves the right to reject any and all bids, in whole or in part, as it determines to be in the best interest of the City.
