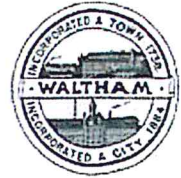

PROJECT DESCRIPTION

GOALS

To purchase UMASS parcels located at 225-227 Beaver Street, 240 Beaver Street, and 240 AFT Beaver Street, Waltham, Massachusetts from University of Massachusetts/Commonwealth of Massachusetts.

COMMUNITY NEED

The UMASS Field Station and farm have long been identified in the City's Open Space Plans. See Attached.

COMMUNITY SUPPORT

The Waltham City Council, Mayor and various community groups/individuals have supported the UMASS farm, its research, its community farms, its education and community outreach and the acquisition.

TIME LINE: ASAP

Working with the local delegation, UMASS will be filing state legislation.

CREDENTIALS

The City of Waltham has successfully acquired from the Commonwealth several state parcels, including the former Fernald School, the former Gaebler Hospital, the former Metropolitan State Hospital and Lot 1.
