MINUTES OF THE TRAFFIC COMMISSION MEETING FEBRUARY 16, 2012 AT 10:00 A.M.

1. PETITIONED ITEMS:

A. Fairmont Avenue – No Parking

Councilor Giordano is requesting No Parking on both sides of Fairmont Ave. near Weston St. due to problems with school buses turning. The Councilor states that due to parking on both sides of the street school buses have a difficult time making the corner. A site visit showed moving the corner restriction will solve the problem. Voted to approve this request and add the following to Schedule #1

Fairmont Ave.: west side from Weston St. to a point 50' south No Parking Fairmont Ave.: east side from Weston St. to a point 65' south No Parking

Schedule #1A Overnight Parking Approved Delete Fairmont Ave. east side entire length

Add: Fairmont Ave. east side, from a point 65' south of Weston St. to Villa Street

B. Maple St. at Prospect St./Crescent St. – Revised Signal Timings

Signal Timings have been revised per Watch Factory's Special Permit. Our consultant GPI & Mr. Kelly Wires Inspector completed their final inspection (Jan.26, 2012) and recommended the revised signal timing be accepted and the Signal Permit to be amended. **Voted to accept their recommendation.**

C. Boston 3 – Day for the Cure Walk July 27-29, 2012

This walk benefits the Susan G. Komen Breast Cancer Walk. Councilor Curtin spoke in favor of this request and Sgt. Devenay WPD recommended approval. The walkers will enter Waltham on Friday July 27, from Newton and use Moody St - Main St. – Linden St. – Beaver St. – Forest St. They will rest at the Gann Academy on Forest St. They will leave at 6:30am on Saturday July 28 using Forest St and Trapelo Road to enter into Belmont. **Voted to approve this walk-a-thon**

D. 1006-1022 Main Street – Special Permit proposal for Chipotle Mexican Grill, Inc.

Kevin Dandrade from TEC,Inc. has submitted a letter on this proposed restaurant. Attorney Joseph Connors appeared on behalf of Chipotle Grill. The proposal is consistent with prior reviews relative to traffic impacts. The impact is still accurate and acceptable as stated in the trip generation analysis. The use does not require additional mitigation. The Commission voted to accept this report and forward this information to the City Council for their deliberations relative to a Special Permit.

E. Riverfest – June 15-17, 2012

Ms. Peggi lebba is requesting permission to hold this event on Moody Street. The request is to close two lanes of the Moody Street Bridge from 10AM to 8PM on Saturday June 16. A regatta will take place from the Prospect Street Bridge to the Moody Street Bridge (a Sprint Race) from 8Am to 3PM. The boaters will stage at the Woerd Ave. boat loading area. The Police Department, Lt. Brooks Community Services Division, has recommended approval for this event and the adequate police protection is provided. **Voted to approve this request.**

F. 18th Annual Boston Brain Tumor Ride – Sunday, May 20, 2012

This ride will benefit the National Brain Tumor Society. The event consist of a 10mile, 25mile and 50mile bike ride will start and finish at 920 Winter Street. The Police Department has recommended this event be approved. **Voted to approve this request.**
