# MINUTES OF THE TRAFFIC COMMISSION MEETING HELD: FEBRUARY 20, 2014 AT 10:00 A.M. HENRY HOOVER COMMITTEE ROOM, CITY HALL

The Chair accepted a motion to accept the minutes of the previous meeting. Voted to accept January's minutes.

### 1. PETITIONED ITEMS:

# A. Main Street Market Place-Highland Hustle 5K

Timothy and Kathy Irving are requesting permission for this race to be held on Thursday, May 22, 2014 at 7:00 PM. . . . Voted to accept the Police Department recommendation and forward to the Mayor's Office for a permit to issue.

### B. Boston Brain Tumor Ride

Jaimee Goodman is requesting permission for this ride to be held on Sunday, May 18, 2014 at 8:00 AM. . Voted to accept the Police Department recommendation and forward to the Mayor's Office for a permit to issue.

### C. Newton Street at River Street – Signal Modifications

Councilor Marchese is requesting that a study be done to determine if the traffic signals need modifications. Residents from the area are seeking relieve from the apparent "cut-through" traffic, particularity during rush hours. Mr. Garvin recommended a study to be done with traffic counts recommendations for this location. Adjustments to the traffic signal timing may possibly improve operations. Voted to direct Traffic Engineering to study signal operations at Newton/River Street.

## D. Stow Street – Heavy Truck Exclusion

Councilor Giordano, is requesting a 24 Hr. Heavy Truck Restriction on Stow Street the entire length.

Chairman, Chief McPherson recused himself on this item due to a possible conflict. Co-Chairman Mr. Magno chaired for this item. Residents of Stow Street have made complaints of large dump trucks coming from the Polaroid site going through their neighborhood. The street is classified as an Urban Collector roadway. Stow Street has an evening truck restriction, 7pm to 7am. All truck restrictions must be approved with a permit issued by MassDOT. One of the requirements for the restriction is an alternate route must be selected from Route 20, Weston Street, to Rt.117, Main Street. The only viable route would be Banks Square (Weston & Main Street) which is over ½ mile to the east. This requirement prevents a permit to be issued. City Clerk, Mr. Malone was requested to review the "Special Permit" issued to Polaroid Site to determine what if any prohibitions were included on the use of Stow Street during the construction phase. Voted to deny a 24 hour truck restriction on Stow Street.
