MINUTES OF THE TRAFFIC COMMISSION MEETING HELD: APRIL 11, 2019 AT 10:00 A.M. HENRY HOOVER COMMITTEE ROOM, CITY HALL

Minutes of the Special March13 meeting and March 21 meeting were accepted. Also, the minutes of the February meeting were amended.

1. PETITIONED ITEMS:

A. Circle Dr. at Hobbs Rd. – Proposed STOP signs

Capt. Donald Russo Traffic Division, is requesting we review to see if this is warranted. Traffic Engineer Mr. Garvin recommended a study of this intersection to determine if a Stop Sign is warranted. **Voted to table and have a report at a future meeting.**

B. Waltham Lions Club Annual Carnival

Julie Monaghan is requesting closing of Waverley Oaks Rd. during certain times May 8-May 12. The request is for Wednesday May 8 to May 10 to close the street from 7:00 PM to 11:00 PM. Saturday and Sunday May 11 and May 12, to close the street from 12:00 PM to 11:00 PM. Parking arrangements have been made at Duffy Brothers property and shuttle service will be provided. In addition Police Officers will be on detail. Voted to approve closing Waverley Oaks Road from Linden Street to Beaver Street at the requested dates and time.

C. 84 Gardner St., Unit 1 – Proposed Disabled Parking Space

Mr. Tyler Thompson is requesting a Disabled Parking space in front of his residence. Mr. Mark Johnson, Chairperson, Disability Services Commission and Traffic engineering both recommended a space be approved. Voted to have an HP space on Garner Street, west side, Opposite #84, Unit#1.

D. 2nd Annual Fitzgerald Fun Run

Ms. Christine Young is requesting permission to hold to event on Thursday, June 20th at 6:00 PM. The race will be in the Warrendale area starting at the Fitzgerald School. Lt. Cavallaro, Community Services, recommended approval. No streets will be closed and there will be Police presence. **Voted to recommend to the Mayor, that a permit be issued.**

E. 1017-1019 & 1025-1075 – Revision to Special Permit

Jason Adams with McMahon Associates and Attorney Michael Connors appeared for the petitioners presenting the revisions. The proposal is to create a surface parking lot, with 44 parking spaces, in the space where the Eastside Motoring (1017-1019 Main Street) building was located, with a connection to the existing parking lot for the office building at 1025-1075 Main Street. The lot located in the northeast corner of Main St./Prospect Hill Road will be abandoned. Traffic Engineer, Mr. Garvin recommend approval. Voted to accept this recommendation and forward it to the City Council for their deliberations to modify the Special Permit for 1025-1075 Main Street.

Fire Chief McInnis stated this would increase problems for fire apparatus trying to enter Main Street. Mr. Garvin agreed that the existing No Parking 60 feet from Main Street would be retained and the 2 hour parking would be extended to School Street. The existing regulation of Lexington St., E. side, Main St to 60' N. No Parking will remain.

Amended is Lexington St. E., side from 60' N. of Main Street to School Street, 2 Hr. Parking 8am-6pm, Exc. Sun & Holi. Voted to approve this amendment.

- C. River/Farwell/Seyon Update Dagle Electric is proceeding with fixing the signals.
- D. High/Hamblin/Joyce Update VHB has submitted preliminary design plans. Member Tim Kelly would like to review whether the No Turn On Red should be removed. Will be meeting with Newton Officials tomorrow (4/12) and seek a neighborhood meeting. Voted to proceed with the plans.
- E. West Side Traffic Study Update funding for study denied at this time by the Mayor until other projects completed.
- F. Citywide Reduced Speed Limit Update funding for study denied at this time by the Mayor until other projects completed.
- G. Proposed FY2020 Budget: Member Mr. Magno recused; voted to submit the budget as recommended by the Traffic Engineer
